THE CURRENT CYBEROO CONTROL SHAREHOLDERS PURCHASE SHARES OF ITSELF FOR A VALUE OF 550.000 EURO FROM SEDOC DIGITAL GROUP S.R.L., OWNED BY THE SAME, SUBSCRIBING A 48-MONTH LOCK UP AGREEMENT

Milan, 2 December 2019 - Cyberoo S.p.A. (the "Company" or "Cyberoo"), Innovative SME specialized in cyber security for companies, announces that today Fabio Leonardi, CEO of the Company and Davide Cignatta, council member of the same, have purchased 137,500 shares (1.45%) of Cyberoo from Sedoc Digital Group Srl.

Fabio Leonardi purchased 100,000 shares (1.05%) for a value of 400,000 euro and Davide Cignatta 37,500 shares (0.39%) shares for a value of 150,000 euros.

The unit value per share was identified as 4.00 euros, higher than the current market value.

Please note that Fabio Leonardi and Davide Cignatta also hold 65.0% and 20.0% of Sedoc Digital Group S.r.l respectively.

EnVent Capital Markets Ltd, following the request for waivers by Sedoc Digital Group S.r.l. who signed a lock-up contract with Nomad for an 18-month period during the admission phase, agreed to release 137,500 shares against the simultaneous signing of a lock-up agreement by Fabio Leonardi and Davide Cignatta for a period of 48 months.
