COMMUNICATION PURSUANT TO ART. 17 OF ISSUERS REGULATION FOR AIM ITALIA: SUBSTANTIAL CHANGE OF SIGNIFICANT SHAREHOLDERS

SDG INNOVATIVE TECHNOLOGIES SRL RISES TO 51% OF CYBEROO FOLLOWING THE CONTRIBUTION OF SHARES BY THE PARENT COMPANY SEDOC DIGITAL GROUP

Milan, 17 December 2019 - Cyberoo S.p.A. (the "Company" or "Cyberoo"), Innovative SME specialized in cyber security for businesses, announces that, following today transfer by Sedoc Digital Group S.r.l. ("Sedoc") in favor of SDG Innovative Technologies S.r.l. (SDG) of n. 1,239,750 Cyberoo shares to release a capital increase in kind of SDG, the shareholders Sedoc and SDG informed today the Company of the occurrence of a substantial change in the stake held in the share capital of Cyberoo, pursuant to "Discipline on Transparency", article 13.3 of the social bylaw and art. 17 of the AIM Italia Issuers Regulation.

In particular, the shareholder SDG, 100% controlled by Sedoc, announced that it now exceeds the 50% threshold by holding 4,844,750 Cyberoo shares equal to 51.0% of the nominal capital. On the other hand, Sedoc's shareholding simultaneously fell from 32.08% to 19.03%

The shares transfering operation was also implemented in order to concentrate the majority of Cyberoo on SDG, as well as to make SDG itself more suitable for any potential new investors interested in supporting Cyberoo's industrial project.
