The Italian company specializing in cyber security ranks third in the category reserved for "Fundraising on the AIM market"

Reggio Emilia, 15 April 2020 - Cyberoo S.p.A, an innovative SME listed on AIM Italia, specialized in cyber security for businesses, received the "Award for the third best capital market use strategy" in the category reserved for fundraising on the Borsa Italiana's AIM market. With this recognition Equita wants to reward the originality and effectiveness of the operations carried out on the capital market as a lever for the relaunch and development of the company, an operation that for Cyberoo successfully translated into the listing of last October.

This year's theme was the analysis of the recent dynamics of the Investment banking market in Europe, in order to identify current trends, possible future developments and the implications for businesses, intermediaries, regulators and policy makers.

The operations and the companies nominated for the Equita Prize were chosen considering those carried out in the period between 1 January 2019 and 31 December 2019. Among the other companies awarded in the same category, also Antares Vision and Pattern.

Nexi, Newlat Food and Salini Impregilo, are instead the winners for the MTA market and Alerion Clean Power, Forgital Group and Tamburi Investment Partners for the best Fundraising on the Debt Capital Market.
