To the three-year contract, which when fully deployed will generate a **total annual value of more than 90 thousand euro** (gross of distributor fees), is added an additional 3 months of free use, as part of the **Defense For Italy** initiative.

With this new customer, Cyberoo confirms its positioning on the **mid-large enterprises market** and further consolidates the increase in average size per single order, on a significantly higher level than that recorded in 2019.
